

IMCD 2017 Conference Registration Terms and Conditions

Your booking and payment

Registration can only be made via the online booking system by PayPal, credit card and bank transfer (EFT). All prices are in Australian dollars and include GST.

Payment will be effective immediately when paying by credit card or PayPal. EFT payments will be subject to confirmation by your bank.

The total price of your booking will be confirmed at the time of the registration and it will include any extras that you have selected such as the accommodation costs for accompanying persons.

Full payment of registration fees must be received prior to the conference. Unpaid delegates will be refused entry into the event, so please ensure that your fees are paid prior to your arrival at IMCD 2017.

This applies regardless of whether you are attending as a delegate, a chairperson or as a speaker.

Cancellation policy and refunds

All cancellations and requests for registration refunds must be made in writing to b.platzer@garvan.org.au.

Cancellations received up to 90 days prior to the commencement of the symposium/conference will be refunded in full, less 25% of the registration fee to cover administration costs.

Cancellations received within 90 days of the symposium/conference commencement date will receive no refund.

A substitute delegate (from your organisation) may attend in your place by prior arrangement with IMCD admin Belinda Platzer (b.platzer@garvan.org.au) where deemed appropriate subject to a \$50 processing fee.

No refunds will be given for non-attendance at the conference.

Accommodation and airline cancellations are at the discretion of the individual organisations concerned.

Insurance

Registration fees do not include insurance of any kind. It is strongly

recommended that participants take out their own general travel insurance before travelling to the conference. It is suggested that the insurance policy should cover loss of fees/deposit, airfares, accommodation charges, medical expenses, loss or damage to personal property and repatriation expenses.

The insurance should cover loss arising from the cancellation of the symposium/conference by the organisers or a person's inability to attend due to any reason whatsoever. No responsibility is taken by Garvan or the conference organisers for any personal injuries, or loss of, or damage to, private property belonging to the symposium/conference participants and accompanying persons.

Privacy

Your name, organisation and country/state may be published in the delegate list which is provided to delegates, exhibitors and sponsors at the event.

Subject to strict conditions of use, your name and contact information may be used by for the promotion of future events of this type. By providing your email address on the registration form you consent to be contacted by these methods in relation to this and future events of this type.
